- 2. The financial results of the company were prepared in accordance with the Indian Accounting Standards notified by the MCA.
- 3. The Company is engaged in the business of Software Development and Consultancy, which is considered by the management as a single reportable business segment.





- 4. The figures for the quarter ended March 31, 2020 were the balancing figures between the audited figures in respect of the full financial year and published year to date figures up to the third quarter ended December 31, 2019.
- 5. The spread of COVID 19 pandemic across the globe and the consequent remedial measures against the virus taken by the various countries and the Indian Government are having impact on the operations of the various economies, all of which has led to substantial contraction of demand.

In view of the above pandemic, its impact on the company's operations has been considered and a sensitivity analysis based on current estimates in assessing the recoverability of receivables also has been performed. However, the actual impact of COVID-19 on the financial statements may differ from that estimated and the Company will continue to closely monitor any material changes to future economic conditions.

6. Previous period/year figures have been regrouped/reclassified wherever necessary.

INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM STANDALONE FINANCIAL RESULTS

TO THE BOARD OF DIRECTORS OF M/S SAGARSOFT (INDIA) LIMITED

We have reviewed the accompanying statement of unaudited financial results of M/S SAGARSOFT (INDIA) LIMITED (the "Company"), for the quarter ended June 30, 2020. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement.

Emphasis of Matter

We draw your attention to Note No. 5 of the statement, dealing with uncertainties thrown up as a consequence of COVID-19 pandemic, management's assessment of impact on financial reporting and future operations of the company and the remedial measure put in place to mitigate the adverse effects. However, the actual impact of COVID-19 on the financial statements may differ from the estimates made by the management.

Our conclusion is not modified in respect of this matter.
